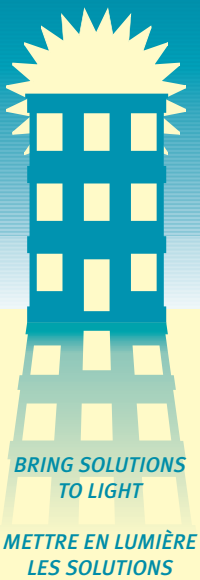

The following provides a brief summary on the key successes and CCSMH Strategic Initiatives that have taken place between January and December 2004.

STRATEGIC INITIATIVE: NATIONAL GUIDELINES

In October 2004, the CCSMH submitted a proposed amendment to the current Health Canada, Population Health Fund grant. Approval was provided for funding, for the creation of National Guidelines for seniors' mental health.

The project goal and objectives are to lead and facilitate the development of evidence-based recommendations for best-practice guidelines in key areas of seniors' mental health. Guidelines will be created for the following four areas:

- Suicide -Assessment and Prevention
- Depression - Detection and Treatment
- Delirium - Assessment and Intervention (including its relationship with complex / concurrent conditions)
- Mental Health Issues in LTC (with a focus on mood and behavioural problems)

CCSMH RESEARCH WORKSHOP:

On September 20th and 21st 2004, 47 key stakeholders gathered in Toronto, Canada for a two-day Research Workshop entitled “Setting Strategies for Research, Partnership and Knowledge Transfer”

Through a combination of speakers, plenary sessions and small group work sessions, the Research Workshop participants accomplished the following:

- The CCSMH pre-workshop environmental scan document was reviewed and outstanding gaps and information were determined.
- Consensus was reached on major research themes pertinent for seniors’ mental health
- Agreement on principles that could be used for setting funding priorities in the area of seniors’ mental health research
- Participants identified key barriers in Canada that prevent the enhancement and advancement of seniors’ mental health research
- Participants identified key opportunities and enablers to creating an enhanced seniors’ mental health

research environment in Canada. Action plans and identification of project leads were noted

- Unanimous agreement was reached to create the “Seniors’ Mental Health Research Network” under the auspices of the CCSMH. Planning for this strategic initiative is underway.

In December 2004, summary notes and a PowerPoint presentation on workshop outcomes were distributed to all Research Workshop participants. Currently, F. Malach and D. Hogan (chair of the Research Workshop Project) are working to finalize the Research Workshop final report and recommendations that will be disseminated to relevant stakeholders over the upcoming months. In addition, a new Seniors’ Mental Health Research Network, chaired by D. Hogan and facilitated through the CCSMH is in its initial planning stages. Special thanks to Health Canada, Population Health Fund, The Max Bell Foundation, CIHR (IA & INMHA) and the CHSRF for supporting this important initiative. STRATEGIC INITIATIVE: EDUCATION – MATERIALS FOR INFORMAL CAREGIVERS OF SENIORS & FRONT LINE WORKERS

To date, approximately 1750 of each educational material catalogue have been distributed across Canada. Receipt of evaluations from the catalogues, indicate satisfaction and the perception that the catalogue is meeting an unmet need. Due to increasing numbers of requests

STRATEGIC INITIATIVE: ASSESSMENT AND TREATMENT GROUP

Under the Chairmanship, of Dr. K. Le Clair, the CCSMH Assessment and Treatment Subcommittee re-established project goals and objectives during the summer/fall of 2004. Currently, the group is finalizing a pilot survey that will be disseminated in the spring of 2005. The survey will focus on:

- What assessment tools are being used by front line workers and what is being assessed?
- Are the assessment tools critical in determining positive outcomes for the patient?
- What are the most critical issues for success with

regards to assessment?

- What are the barriers or challenges with regards to assessment (tools, process, policy)?
- What do front line workers need to assist them in flagging and identifying mental health issues?

CAMH HEALTHY AGING PROJECT: DEVELOPING RESOURCE MATERIALS AND TRAINING FOR SERVICE PROVIDERS WHO WORK WITH OLDER ADULTS

The purpose of the Centre for Addiction and Mental Health's Healthy Aging Project is to develop training and resource materials on mental health and substance misuse issues in older adults for those who work with older adults in Ontario and beyond.

Specific objectives are to:

- increase the knowledge, comfort and confidence in working with older adults who may have mental health, substance use and/or gambling related problems
- increase provider's skills and abilities specific to their positions and settings
- remove barriers to services
- contribute to improving community response to older adults with these problems.
- highlight diverse groups of older adults and their distinct needs

Project outcomes will be:

- a stand alone comprehensive resource manual for health and social service providers who work with older adults about mental health, substance misuse, gambling and concurrent problems in older adults, and
- several training modules that will be launched simultaneously as part of a training strategy in late 2006.

This new material forms a "suite" of training options and publications that will be mutually complementary and will include the existing CAMH publication *Choosing to Change*, and an upcoming booklet for workers and volunteers titled *Responding to Older Adults with Mental Health and Addiction Challenges*. Two new public information brochures are also forthcoming, one on substance use and another on mental health issues in older adults. The project is being developed by an interdisciplinary team within CAMH and with external advice, consultation and review from others in the field.

"QUESTIONS FROM THE FIELD: A PRACTICAL RESOURCE MANUAL ABOUT MENTAL HEALTH, SUBSTANCE USE AND GAMBLING ISSUES FOR THOSE WHO WORK WITH OLDER ADULTS"

This Resource Manual will provide information, tools, resources, best practices and community strategies about how to respond effectively to older adults who may have mental health, substance use or gambling problems, or a combination of problems, sometimes known as concurrent disorders. This resource is designed for service providers who work with older adults in a variety of settings including long-term care homes, housing and retirement facilities, and in the community. It is directed at those in a wide variety of both paid and volunteer positions: frontline workers, nurses, health care aids, personal support workers, meals on wheels volunteers, occupational therapists or physiotherapists, counselors, housing superintendents, home support workers, administrators, managers, educators, planners, and policy makers. This manual will be a useful resource for mental health and addiction organizations as well as a curriculum resource for post secondary programs in health and social service disciplines.

The Manual will be produced by CAMH in 2006 as a

three-ring binder presenting comprehensive background information, key concepts, using case studies and applicable tools such as FAQ's, checklists, questionnaires and brief tips that can be re-produced. Several authors including Charmaine Spencer of the Canadian Seeking Solutions Project, are writing original material, and some existing material will be reformatted for the manual with acknowledgements and copyright permission. It will be prepared in full as a web resource, as well as being made available for a reasonable cost as a hard copy manual.

TRAINING

Several training modules will be developed to address the learning needs of the various target groups of service providers, including mental health and addiction service providers, and senior-serving organizations. A strategy to best provide training to the multiple audiences is being developed.

BEST PRACTICE GUIDELINES FOR OLDER ADULTS WITH DELIRIUM, DEPRESSION AND DEMENTIA

The Registered Nurses Association with funding from the Ontario Ministry of Health and Long Term Care has produced and published two pivotal Best Practice Guidelines for nurses practicing in acute, community and long term care settings to facilitate appropriate screening and care strategies for older adults experiencing delirium, depression and dementia. The "Screening for Delirium, Dementia and Depression in Older Adults" best practice guideline, published in 2001 was established to enhance mental status assessment in clinical nursing practice.

The most recent best practice guideline "Care Strategies for Older Adults with Delirium, Depression and Dementia" was published in June 2004 to provide nurses with researched care approaches for older adults (65 years and older).

In January 2003 the RNAO convened a meeting of selected nurses and researchers with expertise in practice, education, gerontology and geriatric mental health to develop the Best Practice Guideline. The panel decided to develop a single guideline with respect to delirium, depression and dementia based on the frequency of symptomatology overlap and co existence of these conditions that can present simultaneously and may require application of various mental status assessment and concurrent care strategies.

A search of the literature for systemic reviews, clinical practice guidelines, relevant articles and web site resources was conducted. Clinical practice guidelines related to geriatric mental health were identified and a quality tool utilizing the Appraisal of Guidelines for Research and Evaluation Instrument (AGREE

Collaboration, 2001) was facilitated. Subgroups with respect to delirium, depression and dementia reviewed the relevant research documents and additional resources to draft recommendations for nursing intervention. A consensus draft was submitted to external stakeholders for review and feedback prior to publication.

The "Care Strategies" guideline describes interventions that address the specifics of Delirium, Depression and Dementia with respect to differentiation of presentation, risk factors and intervention strategies based on established tenets of care. Detailed resources for assessment, intervention, protocol, policy and education are provided and referenced.

The guideline directs key recommendations for:

- (1) Nursing practice: all nurses to assess and provide intervention for all three conditions:
 - (2) Education: to educational institutions and organizations to support implementation of the guideline in clinical settings
 - (3) Organization and Policy: directed to practice settings to facilitate nursing best practice;
 - (4) Evaluation and monitoring : the impact of best practice.
- These best practice guidelines provide a foundation for clinical nursing practice to address the complexities of assessment and individualized care strategies for older adults experiencing delirium, depression and dementia across the health care continuum.


